## Baker School District 5J – 2021 Seismic & 2021-23 Capital Bond Projects Quote Request for Special Inspections and Testing Services

Baker School District 5J ("District") is conducting a competitive quote process for consultation services for Special Inspections and Testing for their 2021 Seismic upgrades and the new construction portion of the 2021-23 Capital Bond Projects.

#### **Project Description**

Nationally recognized Baker School District 5J in Baker City, Oregon, is the largest of three rural school districts in Baker County, serving 1,700 students and employing more than 235 educators and staff. There are approximately 1,010 elementary students (grades K-6), 260 middle school students (grades 7-8) and 430 high school students (grades 9-12).

The intended scope of the 2021 Seismic Bond program addresses the structural upgrades to Wing 3 of Brooklyn Primary School and the Baker Middle School Gymnasium. Whereas, the new construction scope of the 2021-23 Capital Bond projects includes a standalone 5,000sf Multipurpose Building adjacent to Helen M Stack Building (Baker Middle School); the building scope will include a new parking lot, multi-use cafeteria space, fully-operational kitchen, and hard connection to the existing Middle School Gymnasium.

The District requires a material testing and special inspection firm to work as part of the design and construction team to ensure the project is constructed in the highest practical quality. The anticipated scope of services includes but not limited to the following:

	material testing and special inspection was to the best of the inspectors'
	knowledge in conformance with the approved drawings and specifications
	and applicable provision of the code. If non-conforming work was observed
	and not corrected, identify the portions of the work that failed to conform.
	Attach the test and inspection reports documenting the non-conforming
	work.

		relevant certifications including Oregon Building Official Association
		(OBOA) Certified Inspectors and Certified Materials Testing Technicians
		near the Union County/Baker County/Malheur County, Oregon area.
4	Certifications	List of respondent firm's professional accreditations.
5	Hourly Rates	Provide detailed list of all hourly rates, unit description and unit price for
		all related testing and inspection services as outlined in the anticipated
		scope of work. Include rates for applicable home office and project
		management functions as well as travel, mileage and per diem, if required.
		Clarify the location which Inspection Personnel will be traveling from to
		allow for estimating of travel related expenses, and ensure transparency is
		given to how travel expenses are calculated.
